Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in the dairy, which will carry 15 marks.
- 4. The fourth component of this paper will be Viva -voce examination on all the above three aspects. This will carry 10 marks.
