1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product

having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

i. If number of technically qualified bidders are only 2 or 3.

- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

FINANCE OFFICER VBSPU payable at JAUNPUR

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

**Submission of Certificates/Documents/EMD DD:** All required certificates, d ocuments, and the EMD Demand Draft must be included in the technical bid en velope. Ensure the bidder's quote, as specified in point 2, is clearly mentioned o n the envelope in capital letters.

**Packaging and Addressing:** The sealed technical bid envelope must be place d inside a larger envelope. **Hard copy Submission Deadline and Method:** The technical bid, along with all required certificates/documents, must be sent to the Registrar's office at the address above within 05 days from the bid closing date. The submission must b e made via by hand Registered Post, Speed Post or Courier.

**Disqualification Clause:** Non-compliance with the above terms will result in t he bid being technically disqualified. Additionally, if any mandatory certificate, r egistration, or document is missing, the tender will be rejected.

**System Performance Record:** List of at least 10 installations of the standard version of quoted item (or similar model) should be provided along with the use rs contact details for system performance. Only systems that receive a satisfac tory report from the user will be considered technically qualified.

**Bidder's Performance Record:** Bidder must have supplies at least 10 *Electro chemical Workstation* and list of users should be provided with contact details ( email & mob. No.) for bidder's service and support performance. Bidders will b e considered technically qualified only if they receive a satisfactory report from the user.

## Installation, commissioning and training

- The pre-installation requirements should be communicated to VBS Purvanchal University well in advance of the installation.
- The installation, commissioning and training must be done only by well trained personnel.
- The vendor should provide training to at least 3 persons at the installation site to make them familiar with the smooth operation of the instrument.
- The product will be only accepted on demonstration of all the specified accurac y, resolution and repeatability of the measurement on the standard sample.
- The delivery should be considered complete only after successful installation, c ommissioning of the instrument and satisfactory report provided by the trained faculty member.

**Service:** Bidder must have response for problem resolving within the 24 workin g hours during the warranty period.

It is important to note that both the system and the bidder's performance recor d must meet the qualification criteria. Non-compliance with either will result in t he bid being technically disqualified.

Vendor should provide the standard samples for testing and calibrating the instr uments at any time for the demonstration of the performance of equipment.
